5. PRESENTATIONS/RECOGNITIONS

- A. WSD Board Policy #1400 Operation During Times of Crises First Reading Mr. Cameron
 - Mr. Cameron explained the necessity of changing from specifics to more generalization in this policy. The specifics are listed in the Emergency Procedures Guide.
 - The language is antiquated and is now updated.
- B. Community Transition Grant Mr. Nichols of Nemours, Mrs. Huskey District Wellness Champion
 - Mr. Nichols and Mrs. Huskey reported on the success of the Community Transition Grant.
 - The grant provided funding to districts to strengthen wellness policies, improve community and parental involvement, and strengthen the school-wide wellness plans.
 - 90% of teachers reported improved engagement with students who are usually challenging to engage following Energizers (short burst of activity).
 - Mr. Nichols and Mrs. Huskey also explained the wellness policy should be re-evaluated yearly and changes made as needed.
- C. Phillis Wheatley School Improvement Team Presentation Mrs. Brown, Dr. Leach, Mrs. Anthenelli, Mrs. Baker, Mrs. Burress, Mrs. Kerrick, Mrs. Propes
 - Goal One: Achieve outcomes for students via college and career ready mindsets, investments, practices, and programs.
 - PWES has met this goal by posting staff credentials, providing Common Core aligned curriculum, holding College Wear Day, College and Career Day, door decorating contests, and Social Skills and Self-Regulation Group.
 - Goal Two: Achieve measurable outcomes for students via a culture of data-driven decision making.
 - The students are assessed through the DIBELS program, STAR Reading/Math, Scholastic Math (SMI), Amplify Benchmark, and Smarter Balance (SBAC).
 - Goal Three: Achieve goals and objectives concerning educator effectiveness.
 - All new teachers must complete the three year mentoring program. The Principals and Specialists
 have regularly scheduled walkthroughs and the District Specialists help coach the teachers with the
 new curriculum.
 - Goal Four: Dramatically accelerate achievement and improve outcomes for all students.
 - This goal is reached through the following:
 - Collaboration through 90 minute weekly PLC meetings to analyze student data, implement RTI's and daily instructional planning.
 - Engaging families through Open House, Curriculum Night, Math Homework Helper, Raider Night and Wonders Reading Showcase Night.
 - The yearly attendance goal is 95%. PWES yearly attendance average is 95.9%
 - Mr. Gilefski complimented Mrs. Brown, Dr. Leach and staff for an excellent job maintaining a high attendance average.
 - Mrs. Brown thanked the Board, Mr. Chasanov, and Mr. Cameron for the support given to the staff and students.
 - Mr. Chasanov thanked the staff and administration of PWES for holding a successful first College and Career Day.

- D. District Strategic Plan 2014-2019 Mr. Chasanov
 - The strategic plan is a five (5) year plan that sets the tone for the School Improvement Plans (SIT).
 - The mission statement remains unchanged.
 - The vision has been changed to "Every student will graduate with the opportunity to pursue postsecondary education and/or enter the career field of their choice".
 - Goal One (1) deals with academics. Goal Two (2) deals with social/emotion/physical needs. Goal Three (3) deals with the facilities.
 - The Plan will be reviewed annually and we will report on whether goals have been met.
- E. WSD Board Policy Section #801 Code of Conduct School Uniform/Dress Code Enforcement Second Reading
 - The changes made to the policy were recommended at the first reading.
- F. WSD Board Policy Section #800 Student Rights and Responsibilities Second Reading
 - The changes made to the policy were recommended at the first reading.
- G. WSD Board Policy Section # 705 Grading Policy First Reading Mr. Chasanov
 - Mr. Chasanov explained the need to change the grading system to a 10 point system.
 - This will help align grading systems with colleges.
 - It will help in increasing motivation for students.
 - Mr. Gilefski agreed that the 10 point grading system is a good change.

- A. March 2015 Budgetary Report Mr. Chasanov
 - As of February tax collection is 99.8% of budgeted amount. We will go over 100% by fiscal year end.
 - We have spent 75 % of the budget being 73% into the year and our salary line is at 72%.
 - No budget lines are over budget.
 - All accounts are in good shape.
- B. 2014-2015 School Calendar Update Mr. Chasanov
 - The State Board approved two (2) days to be forgiven for staff and seniors.
 - The staff missed five (5) days so three (3) days must be added. This will make the last day for staff a half day on June 18, 2015.

- The end of the year events involving the senior class will not be changed. Three (3) days prior to graduation (May 26, 27, and 28, 2015) will be filled with graduation activities and classroom activities.
