- Goal #1: Achieve outcomes for students via college and career ready mindsets, investments, practices, and programs, while moving to higher standards for student performance. This is being achieved by doubling honors classes; 2 classes each of Reading and Math at all grade levels, and by using Cooperative Learning to engage students and build understanding focused on CCSS increased rigor and student expectations.
- Goal #2: Achieve measurable outcomes for students via a culture of data-driven decision-making and accountability, which includes stakeholder collaboration around student success. PLC’s meet two (2) times a week with a focus on curriculum and instruction. District Specialists continue to meet and work with staff in content related areas, continuing to build curriculum within CCSS expectations.
- Goal #3: Achieve goals and objectives concerning educator effectiveness via a deep focus on talent acquisition, education, evaluation, and development, prioritizing work across all elements of the talent cultivation and management spectrum. This goal is being achieved by the DPAS process being implemented with all supervised staff, professional development planned in response to teacher needs and requests, and District mentoring program with 15 staff members.
- Goal #4: Dramatically accelerate achievement and improve outcomes for all students with deep support for the lowest achieving school within an LEA. Over 3,500 positive parent contacts have been made to date. A school-wide “make-up” work policy has been established. Weekly student centered Advisor/Advisee program has been implemented. Weekly team meetings regarding students and student success and continued needs are held.
